Please fax the included paperwork to us at **972.535.1668** **OR** scan and email to: **Info@CheatersSpyShop.com** to complete the activation process. If you activate before 3 PM CST, your tracker will be activated the same day. If your paperwork is received after 3 PM CST, your tracker will be ready to use the next business day.

After activation, the credit card you provided will be charged a prorated amount to pay for the remainder of the current month. For example, if your tracker is activated on the 25th, you will be billed a prorated amount (\$1.33 per day) for the period from the 25th to 30th.

You will be billed once each month until you notify us by email at **Info@CheatersSpyShop.com** that you wish to cancel your service. Billing for your monthly service in the amount of \$39.99 will occur on the 20th of each month. If you notify us before the 20th of the month, you will not be charged for the next month.

If the charges for your monthly billing are declined on the credit card you provided for billing, we'll attempt to contact you at the email you provided.
